Cleaning was very intense as the vent is not straight up and down but curved. The invoice is \$1500. The garbage disposal needed to be replaced. The invoice is \$1507.24. - 2. The Christmas party will be held on the first Sunday of January, which this year would be January 7, 2024.

  - Discussion on caterer, food, cost, time, charge \$5 to attend. Options are Ambrosias—No delivery—\$14.50, Bootleggers--\$13.00, will deliver, set up, served with utensils, and broken down, desserts are extra, Jordan Bar—Chicken only, Amherst Family Foods---Chicken 100 pieces or more \$!.29 apiece and sides by the pound, Metro Market—chicken only, and Legacy Restaurant--\$14.99 per person. Motion to approve trying Bootleggers with meat options being chicken and beef tips was made by Audrey Gagas and seconded by Dorothy. Motion passed unanimously by voice vote. A Dessert sign-up sheet was passed around for donating desserts for the Christmas Party.
