Opening Prayer was led by Debbi Adamski, President.

Reports:

1. Reading & approval of February 12, 2024 meeting – Chris Zinda

Sue Wanta moved for approval. Seconded by Ruth Pritz. Motion passed unanimously by voice vote.

2. Financial Report – Judy Wroblewski

St. Ambrose PCCW General Fund - \$4,831.48 - \$40,000.00 was withdrawn to pay for the pews.

St. Ambrose Seminarian Fund - \$2229.35

PCCW Active checking account – February balance \$8,875.98

March current balance \$12,130.13

Ann Omernik moved for approval of all the financial reports. Linda Burant seconded the motion. Motion passed unanimously by voice vote.

3. Cookbook Account – Betty Kowalski

St. Ambrose PCCW Cookbook Fund - \$3,442.57 - \$10,000.00 was withdrawn to pay for pews. Five cases of cookbooks remain to be sold. A suggestion was made to reduce the price of the cookbooks. No action was taken.

2. Ponczka Sale update on sales.

 - Set up Home and School will be providing place mats.
 - Entrée Spagetti and bread sticks Home and School will in work the kitchen.
 - Salad PCCW will take care of the lettuce salad and fixings. Betty Ostrowski will
 check on lettuce cost. Barb Lepak indicated that some food items could be
 purchased thru CISCO. Debbie Adamski was provided with the food list.
 - Desserts PCCW will supply deserts. An announcement will be in the bulletin requesting donations.
 - Beverages white and chocolate milk, water and coffee will be provided. Soda will be sold for \$1.00/can by PCCW.
 - Clean up Both Home and School and PCCW will clean up. Home and School will find dishwashers.

A sign-up sheet was passed around for PCCW volunteers.
